Almost all the claims on Molokai are without counter claims. There are very few counter claimants to any piece of land there. I have abbreviated some terms as for inst. Kon= Konolaiki; Ah.= Ahupuaa; Wcourse= Watercourse. Molokai lies almost parallel therefore they universally use the word Manae for towards the Windward, Malalo for toward the Leeward, which I have abbreviated here. (v. 6/b)

Vol. 6 Testimony in English

Records of Commissioners Court for Quieting Land Titles Held at Various Districts of Molokai. Witness Kaluaaaha. (v. 6/1)

3985 Holulu Evid. Has seen the land in Kaluaaha Namoo the Ili consists of three parts.

1st part a Kalo patch, Mauka road, Mapulehu side Kemoku, Makai Ulaweli, Malalo Ualapue, Kualualu, this land given by Kauakahi Konohiki at that time under Hoepili previous to the year 1839, does not know any other claimant.

2nd part in Kaluaha also a Taro patch. Bounded Mauka Pulehu, Mapulehu, Aukai, Ual Kohaku makaliilii.

3rd a house plot, Mauka a road, Map. Aukai and Mak Hulul, Ual, Eaanui. Received these 2 parts from Hulu Konohiki of Paki about the year 1836, part 3 fenced, without a counter claimant.

Keauwai sworn knows not but has heard from Kekauluohi in an assembly at Lahaina consulting about the governorship of Maui in the room of Hoapili deceased, witness heard Kekauluohi say she had given two Pukoos to Ilae from the King because of Ilae's living Pilikia on Molokai without any permanent place of residence she gave this for the sustenance of his wife and family for their benefit. Present in said assembly Kenaina, Kepena and others.

A counter claim was sent in to Land Commission for the Fishpond of Pukoa during the time land claims were collected and counter claim was sent in by C.B. Andrews by direction of Wm. Richards, Minister of Public Instruction and Fishpond was affirmed to have been built by all of the people of Molokai, is the fruit of their labors and toil in former days, when they were drafted and commanded by Lunas and chiefs from every point of Molokai and brought to that work, and they further affirm that said pond not having been built by the private labor of any one chief with his Poalima but as aforesaid by all the people of Molokai, it aught not by right of justice to be [?] owned by any one chief or his or her favorite, much less, that the fruit of their toil and sweat should belong to one who has oppressed the people in his living as Luna Auhau on Molokai as Ilae has oppressed them, and enriched himself from the office he held over them. There is a large amount of property on Molokai who consisting of Taro patches and Fishponds they were built with immense labor by all the people unitedly which now is decided to belong to the Peahao or school property and for years ever since Ilae claimed and used so [?] the proceeds of such lands and ponds have gone to the Paahao. It was the opinion of Wm. Richards and also of the present Minister of Public Instruction that said Fishpond of Pukoa and its proceeds rightfully in justice belongs to said Paahao or school property. This statement entered and subscribed by C.B. Andrews.

Lokameikai sworn, and he helped to build the wall of Fishpond of Pukoa under Naea Luna Aukau about the year 1823. All the people were called to this work from Kamaloo to Halawa Kawelo of Kalapue sworn he helped build said Fish pond wall at the command of Naea, women and children also went and worked in the sea gathering lime for said wall.

Haluna sworn lived at Kamaloo in days of Naea and with all people from Kamalo to Halawa was commanded and sent to built Fishpond wall in sea of Pukoa said testimony confirmed by multitudes, listening who said they were fellow workers. (v. 6/10-11)
